

The Bidders/Fabricators for below mentioned in S.No.1 Contract identification HRM.TB-01/077/078 with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements
- 4. Bidder have the option of submitting their bid electronically only. Submission of Hardcopy bid shall not be entertained. Bidders can down load the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the non-refundable fee of NRs. 3000.00 as the cost of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Electronic bids must be submitted to the office Helambu Municipality, Office of the Rural Municipal Executive, Helambu, Sindhupalchowk through PPMO website: www.bolpatra.gov.np/egp on or before 12:00 noon on 03 Oct 2020 .Bids received after this deadline will be rejected. Bidders are requested to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2073 and User manuals issued by PPMO which are available in e-GP system.



- The bids will be opened in the presence of Bidders' representatives who choose to attend at 11:00 am on 4 Oct 7. 2020.at the office of Helambu Municipality, Office of the Rural Municipal Executive, Helambu, Sindhupalchowk. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of as mentioned in para 10, which shall be valid for 30 days beyond the validity period of the bid.
- If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
