Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.51,00,000.00, which shall be valid for 30 days beyond the validity period of the bid.
